Name of Competition	Library Artwork Competition
Eligible Entrants	Entry is open to current Deakin students.
Competition Period	The competition commences at 8.00 am AEST on Monday 16 September 2024 and closes at 11.59 pm AEST on Sunday 13 October 2024.
How to Enter	Entrants must submit their entry using the submission portal, providing all information and uploading a print-ready file. There is no charge to enter this competition. Entrants may enter multiple submissions.
Selection of Winners	Winners will be determined by a panel of Deakin Library staff by Friday 18 October.
The Prize	There is 1 prize of a \$1000 artist fee.
Notification of Winners	The winning artist will be notified via the email provided in the submission form on Friday 18 October 2024.
Delivery of Prizes	The winning artist will be paid a fee of \$1000, following the University receiving a correctly rendered tax invoice for this amount.
