Latin America and Australia South-South Symposium

The signing of the Peru-Australia Free Trade Agreement (PAFTA) and the release of the Victorian Government's Latin America Trade and Investment Strategy, both in 2018, suggest that Australia's business relations with Latin American countries are growing, but there is still little public discourse about people-to-people relations between the two regions. The South-South Symposium provides a forum for discussions about the present and future of relations in the education, academic, and community sectors between the two regions.

The 'South' is not only a reference to geographical latitudes, but is also conceived in terms of historical and contemporary convergences. For example, while there are obvious differences between Australia and the countries of Latin America, there are many commonalities, including a shared history of colonial encounters, indigenous traditions and knowledge, and multiple waves of European and Asiatic migration.

Deakin University brings scholars from Latin America and from bilateral agencies to explore these themes in the South-South Symposium, consolidating existing institutional and researcher links, and fostering new international collaborations.

Building on existing research collaborations amongst the participants, the South-South Symposium will be organised across two primary research streams, 'Education' and 'Humanities and Social Sciences'. A third stream showcases the contemporary thinking of industry and government stakeholders in this relationship, to reflect on and share their work across Latin America and Australia.
